STATEMENT IN SUPPORT OF  
A RESALE AGREEMENT AMONG VERIZON NORTH INC. F/K/A GTE NORTH  
INCORPORATED, VERIZON SOUTH INC. F/K/A GTE SOUTH INCORPORATED,  
AND CAT COMMUNICATIONS INTERNATIONAL, INC. D/B/A CCI

Verizon North Inc. f/k/a GTE North Incorporated and Verizon South Inc. f/k/a  
GTE South Incorporated, Joint Petitioners herein, and pursuant to Ill. Admin. Code tit. 83  
§ 763.110(a), make the following verified Statement in Support of a Resale Agreement  
Among Verizon North Inc. f/k/a GTE North Incorporated, Verizon South Inc. f/k/a GTE  
South Incorporated and Cat Communications International, Inc. d/b/a CCI.

1. The filed Resale Agreement (“Agreement”) among Verizon North Inc. and  
Verizon South Inc. (collectively, “Verizon”), and Cat Communications International, Inc.  
d/b/a CCI, Exhibit 1, was voluntarily negotiated among the parties.

2. Verizon will make the arrangements set forth in the proposed Agreement available, on the same terms and conditions, to any duly authorized telecommunications carrier operating in Verizon's territories within the State of Illinois. Thus, the filed Agreement is not discriminatory.

3. Among other things, the filed Agreement establishes the terms and conditions for the resale of telecommunications services. Such agreements are to be encouraged. Thus, the filed Agreement is consistent with the public interest, convenience, and necessity.

4. The rates set forth in the agreement are reasonable and compensatory.

THEREFORE, Verizon North Inc. f/k/a GTE North Incorporated and Verizon South Inc. f/k/a GTE South Incorporated respectfully request that the proposed Resale Agreement Among Verizon North Inc. f/k/a GTE North Incorporated, Verizon South Inc. f/k/a GTE South Incorporated, and Cat Communications International, Inc. d/b/a CCI be approved as filed.
