

Wisconsin Central Ltd. files the following exceptions to the proposed orders in the above-referenced proceedings.


In the proposed orders for T00-0031, 0032 and 0034, the proposed order states that Mr. Tom Klemm testified that the existing crossings with the Wisconsin Central Ltd. tracks at Central Road, Kensington-Foundry Road, and Wolf Road have no useful life remaining. That is not correct. Mr. Klemm testified that these crossings are nearing the end of their useful life.

Regarding T00-0035, involving the crossing of the Wisconsin Central Ltd. tracks at Camp McDonald Road in Prospect Heights, the proposed order states that Mr. Klemm testified that the existing crossing has no useful life and directs Wisconsin Central to replace the existing crossing. In fact, as Mr. Klemm actually testified, the crossing is a rubber crossing that was installed last year and is not in need of replacement.

Wisconsin Central requests that the final order in T00-0035 not require the replacement of the existing crossing.
