**PETITION FOR EXTENSION**

Now comes Wisconsin Central Ltd. ("WC") and petitions the Illinois Commerce Commission (the "Commission") for an order giving WC an extension to comply with the mandates of the Commission in this docket. In support of its Petition, WC states as follows:

1. WC is a rail carrier operating in Illinois and is a rail carrier within the meaning of the Illinois Commercial Transportation Law.
2. The Illinois Department of Transportation ("IDOT") is an agency of the State of Illinois and is subject to the jurisdiction of the Commission.
3. Antioch Township is a political subdivision within the State of Illinois and is subject to the jurisdiction of the Commission.
4. Lake Shore Drive is under the jurisdiction of Antioch Township.
5. WC operates a line of railroad through Antioch Township; this line crosses at-grade with Lake Shore Drive.

6. Pursuant to an order in this Docket dated May 8, 2002, the Commission required that WC construct an additional track and grade crossing across Lake Shore Drive in Antioch Township, Lake County, Illinois.

7. WC currently has until February 8, 2004, to complete the work described in Paragraph 6.

8. WC has installed the new crossing as ordered, but prior to completion, it needs to undercut the existing main line so that both tracks are at the required elevation. WC had planned on doing this undercutting at the end of November, 2003, but an early freeze at Thanksgiving time prevented WC from doing so. WC plans on doing the undercutting as soon as warmer weather allows.

9. WC is requesting an extension of time until April 30, 2004, to complete the work mandated by the Commission in ICC Docket T02-0011.


WHEREFORE, Wisconsin Central Ltd. respectfully requests that the Commission:

a) Give Wisconsin Central Ltd. until April 30, 2004, to complete work mandated in the order dated May 8, 2002 in this Docket; and

b) Provide such other and further relief as the Commission deems just and appropriate.






