FOURTH REPORT

The Peoples Gas Light and Coke Company ("Company") respectfully submits this fourth report, for the period ended December 31, 2003, with respect to the bonds authorized by the order of the Commission entered on February 11, 2003, in the above-entitled Docket No. 03-0066.

On February 20, 2003, the Company issued \$50,000,000 principal amount of its First and Refunding Mortgage Bonds, Series LL, to the Illinois Development Finance Authority ("IDFA"). IDFA contemporaneously sold \$50,000,000 principal amount of its Gas Supply Refunding Revenue Bonds, Series 2003B to the underwriters, LaSalle Capital Markets, A Division of ABN AMRO Financial Services Inc., and Loop Capital Markets, LLC at 100.00% of the principal amount (i.e., \$100.00 per one hundred dollars face amount) for an aggregate consideration of \$50,000,000, which was then loaned by IDFA to the Company. The Series LL Bonds, which will mature on February 1, 2033, bear interest at a rate of 3.05% per annum.

The proceeds realized from the issuance of the Series LL Bonds

have been used to redeem the Company's previously issued \$50,000,000, First and Refunding Mortgage Bonds, Series GG.

No entity is or became an "affiliated interest" of the Company within the meaning of section 7-101 of the Illinois Public Utilities Act as a result of acquiring the Series LL Bonds.

During the period ended December 31, 2003, the Company incurred no expenses in connection with the issuance and sale of the bonds described in this docket:
