ANSWER TO COMPLAINT

COMES NOW MidAmerican Energy Company ("MidAmerican") and for its  
Answer to the Complaint of Clayton H. Weisenborn states:

1. Mr. Weisenborn states he sold a property including 4107 – 18<sup>th</sup> Avenue, Rock Island, Illinois, late in 1997; MidAmerican denies this allegation for lack of knowledge.
2. MidAmerican denies that Mr. Weisenborn then informed MidAmerican that he had done so.
3. MidAmerican admits that Mr. Weisenborn received a bill for service at 4107 – 18<sup>th</sup> Avenue, Rock Island, Illinois for the period December 1998 through July 1999 in the amount of \$501.15.
4. MidAmerican admits that after service in the customer name of Clayton H. Weisenborn finalized for the residential account at 4107 – 18<sup>th</sup> Avenue,


Rock Island, Illinois, the balance was transferred to a current residential account for Clayton H. Weisenborn at 440½ -19<sup>th</sup> Avenue, Moline, Illinois.

5. MidAmerican hereby incorporates by reference the attached narrative as substantiated by MidAmerican's records concerning Complainant's account at 4107 – 18<sup>th</sup> Avenue, Rock Island, Illinois, as Attachment I.

WHEREFORE, MidAmerican denies Mr. Weisenborn is entitled to any relief in this action as, absent a request from Mr. Weisenborn to discontinue service at 4107 – 18<sup>th</sup> Avenue, Rock Island, Illinois, in his name, MidAmerican continued to provide service and billings to Mr. Weisenborn's account, until the account was finalized in July 1999, which actions MidAmerican was obligated to perform under the regulations of the Illinois Commerce Commission.






