**ERRATA TO MOTION FOR ORAL ARGUMENT**

*NOW COME*, Gridley Telephone Company, Flat Rock Telephone Co-Op, Inc.,  
Cambridge Telephone Company, Henry County Telephone Company, LaHarpe Telephone  
Company, Hamilton County Telephone Co-Op, McDonough Telephone Cooperative, Inc.,  
Moultrie Independent Telephone Company, McNabb Telephone Company, Reynolds Telephone

Company, Adams Telephone Co-Operative, Cass Telephone Company, Shawnee Telephone Company, C-R Telephone Company, The El Paso Telephone Company, Odin Telephone Exchange, Inc., Yates City Telephone Company, Kinsman Mutual Telephone Company, Stelle Telephone Company, Mid Century Telephone Cooperative, Wabash Telephone Cooperative, Inc., Leonore Mutual Telephone Company and Grandview Mutual Telephone Company and, through their attorney, provides the following corrections to their Motion for Oral Argument:

1. In paragraph 2 of the Motion for Oral Argument, Petitioners referred to a Company estimate relied upon by the Commission in its Order in Docket No. 03-0731. Petitioners stated that the Company estimate in Docket No. 03-0731 equaled \$0.87/month. The cited Order actually does not identify a company estimate (since the company did not provide such an estimate in that docket), but identifies a Staff estimate of \$0.82/month. *See* Order in Docket No. 03-0731 at 7.
2. Similarly, in Paragraphs 2 and 4 of the Motion for Oral Argument, Petitioners referred to a Staff estimate relied upon by the Commission in its Order in Docket No. 03-0731. Petitioners stated that the Staff estimate equaled \$0.32/month. The cited Order actually identifies a second Staff estimate of \$0.38/month. *See* Order in Docket No. 03-0731 at 7. The difference in the two Staff estimates relates to whether or not the cost of transit and transport is included. Petitioners' error was inadvertent.
3. As a result, the reference to the company estimate in paragraph 2 should bear the clarification that it is Staff's modification of the company's overall cost estimate, including transit and transport. More importantly, the reference to the \$0.87/month estimate should be and hereby is corrected to the actual \$0.82/month and the references in paragraphs 2 and 4 to the \$0.032/month estimate should be and hereby is corrected to the actual \$0.038/month estimate.

4. Correcting this error does not change the substance of Petitioners' position or argument in its Motion for Oral Argument.

5. Petitioners will file a corrected copy of its Motion for Oral Argument if so requested by the Commission.
