In addition, each month in which the subscriber uses this service, the subscriber will be billed a monthly recurring charge as set forth in Section IX of this tariff. Service is billed each month via the local exchange company bill unless an alternative billing method is established by the Customer. Existing subscribers who wish to select this service are required to contact the Company's Customer Service to change programs.
