Subject: The "Kid" at ComEd are at it again; re: ICC 04-0457

Once again the "Children" in charge of ComEd Oak Brook just don't get it. Believing that they are above the law these kids sent out another "Final Notice prior to Disconnection". This notice states that my power will be shut off on the date, believe it or not, one day after ComEd's was scheduled to make an appearance before the ICC on my charges of their embezzlement, fraud, life and safety issues and a multitude of admitted violations of Title 83 of the Illinois Administrative Code. ComEd Chicago has requested a continuance of the hearing because Mr. John Parise is on vacation. Mr. Parise, Senior Administrator, Regulatory Strategies and Services is suppose to be the person who knows the most about this case; even though he has only been involved since I sent my letter to the Governor in May of this year. (ComEd began corrupting my services in June 2000.) Previously in Mr. Parise's letter he confirmed that ComEd's records were inaccurate.

This "Final Notice prior to Disconnection" document is a threat to perform a terrorist act against myself, my family and/or my property if I don't "COVER" their embezzlement amount and provided a deposit.

I have never had a late payment and all by my billing statements were paid on time and in full for over twenty years! Once more ComEd Oak Brook is only going by what their admitted flawed records show. ComEd has admitted using the funds that I have sent in accordance with Title 83 of the Illinois Administrative Code and using those funds for some other purpose. They've admitted, when they confirmed that they obstructed justice by destroying public records, that they are a criminal organization. Now it appears that they are once again requesting to be declared a terrorist organization too.

After much deliberation, I returned the "Final Notice prior to Disconnection" to the kids in charge of ComEd Oak Brook. I could have just let them turn off my power and sue them for this violation of Title 83 of

the Illinois Administrative Code but I thought it was only fair since ComEd Oak Brook doesn't have a clue on what they are doing. In 37 months at my previous address they never got the service address correct in violation of Title 83 of the Illinois Administrative Code and it took them 18 months to send a billing statement to the correct mailing address that they have previously sent to for 7 years. In 14 months the neither my billing address nor my service address is my actual home address.
