Pursuant to 83 Illinois Administrative Code Section 200.200, The Peoples Gas Light and Coke Company ("Peoples Gas"), by one of its attorneys, Gerard T. Fox, hereby petitions this Commission for leave to intervene in the above-entitled cause, and in support of this petition state as follows:

1. Peoples Gas is a corporation organized and existing under and by virtue of the laws of the State of Illinois, having its principal offices at 130 East Randolph Drive, Chicago, Illinois 60601, and is engaged in the business of purchasing, producing, storing, distributing, selling and transporting gas to approximately 841,000 customers in the City of Chicago. Peoples Gas is a public utility within the meaning of the Public Utilities Act ("Act").


