VERIFIED PETITION

Illinova Electric Partners, Inc., ("IEP") petitions the Illinois Commerce Commission ("Commission") for an order allowing IEP, which is an affiliate of Illinois Power Company, to surrender, and therefore cancel, its Certificate of Service Authority as an Alternative Retail Electric Supplier ("ARES") in Illinois. IEP waives its right to a hearing in this matter. In support of this Petition, IEP states as follows:

1. On December 8, 1999, the Commission, by order, granted IEP the Certificate of Service Authority to operate as an ARES. The certificate authorized the sale of electricity and single billing to nonresidential retail customers with total maximum electric demand of 1 MW or more in the state of Illinois with the exception of the service area of Illinois Power Company.
2. There are no power contracts in existence for IEP and IEP has made no sales as an ARES in Illinois in 1999 or 2000.
3. IEP's bond, which is required under 83 Illinois Administrative Code Part 451, expired September 20, 2000.

4. IEP is an affiliate of Illinois Power Company. On February 1, 2000, Illinois Power Company merged with Dynegy, Inc. Dynegy Energy Services, Inc., ("DES"), which is a certified ARES in Illinois, is a subsidiary of Dynegy, Inc. (Docket 00-0008, approved 2/9/00). DES has power contracts with customers in Illinois and is doing business as an ARES.

WHEREFORE, Illinois Electric Partners, Inc. respectfully requests the Commission enter an order approving the surrender, and therefore cancellation, of its Certificate of Service Authority as and Alternative Retail Electric Supplier in Illinois. IEP has waived its right to a hearing in this matter.


