**MOTION OF THE STAFF WITNESSES  
TO EXTEND BRIEFING SCHEDULE**

Now come the Staff Witnesses of the Illinois Commerce Commission by their attorney, James E. Weging, and move to extend the existing schedule for all parties in the above captioned matters.

1. The initial briefs for Staff Witnesses and Illinois-American Water Company are due on March 4, 2005, with Respondents' Responsive Briefs due on April 1 and Reply Briefs on April 29.

2. Because the wife of the counsel for Staff Witnesses has recently undergone surgery and because of the other matters being handled by said counsel, notably the PGA reconciliation cases for Peoples Gas, Light & Coke Co. and North Shore Gas Co., Ill.C.C. Docket Nos. 01-0707 and 01-0706, which will be coming to hearing the week of March 14, 2005, the briefs on behalf of the Staff Witnesses will not be prepared in time.

3. Staff Witnesses ask that the initial briefs be extended to April 4, 2005, with the Responsive Briefs set for May 2, 2005, and Reply Briefs accordingly extended to May 31, 2005.

4. Although counsels for the Respondents and Illinois-American Water Company had been informed earlier of the possibility of the need for such an extension, Mr.

Goldstein and Ms. Sullivan were telephoned and e-mailed on March 2, 2005, concerning this extension. Ms. Sullivan had no objection provided Illinois-American Water Co. filed its briefs at the same time as Staff.

5. Although no objection to the extension of the initial briefs is expected from the attorney for the Respondent, the proposed dates for the Responsive and the Reply Briefs have not been cleared by him for potential conflicts. However, Staff Witnesses have no objection if the Responsive and Reply Briefs need to be extended further to avoid any such conflict.

**Wherefore** the Staff Witnesses of the Illinois Commerce Commission ask that the briefing schedule be reset as indicated above.
