PETITION TO INTERVENE

BlueStar Energy Services, Inc. ("BlueStar"), pursuant to 83 Ill. Admin. Code § 200.200, hereby petitions the Illinois Commerce Commission (the "Commission") to be permitted to intervene as a party in the above-captioned proceeding. In support of its Petition, BlueStar states as follows:

1. On February 25, 2005, Commonwealth Edison ("ComEd") submitted to the Commission proposed tariffs for market value methodology relating to the post-2006 competitive electric market, and proposed changes to Rider PPO and other rates and riders. The Commission suspended the proposed tariffs on March 9, 2005.

2. BlueStar is a certified alternative retail electric supplier ("ARES") in the ComEd service territory, by virtue of the Commission's Order in Docket No. 04-458. On August 4, 2004, the Commission granted to BlueStar service authority for all eligible nonresidential customers in the ComEd service territory with annual electric consumption greater than 15,000 kWh.

3. BlueStar is an independent ARES, unaffiliated with any utility or generation assets, with offices in Chicago and Peoria. BlueStar services commercial, industrial, and governmental customers throughout the ComEd and other service territories. As such, BlueStar has a substantial interest in this proceeding because any Order will have a direct impact on the progression of a competitive market in Illinois in the post-2006 environment.






