2 services; is that correct?

3 A That's absolutely correct.

4 Q And is the name that is to appear on that  
5 certificate the same name that appears on the  
6 application?

7 A Yes.

8 Q Will there be any assumed names or doing  
9 business as names?

10 A Not in the state of Illinois that the know  
11 of at this moment. There are some other names in  
12 different states.

13 I don't know if you need that  
14 information.

15 Q No, we'll just concern ourselves with  
16 Illinois?

17 A Okay.

18 Q And this is a Nevada corporation?

19 A Yes, it is.

20 Q And is it located in Nevada?

21 A No, it's -- well, we have an office in  
22 Nevada, but we don't have a major operation down in

1 Nevada.

2 Q And where would the books and records be  
3 located?

4 A The financial books are with me in **Naples**  
5 **(ck)**, Florida.

6 Q And is that -- was that accurate to say  
7 that that's where the main office of the company is?

8 A No, I would say the main office would be  
9 the Nevada address.

10 Q Okay.

11 A We outsource all of our work to different  
12 vendors.

13 Q Okay. But you said that the books and --  
14 the financial books and records are with you?

15 A Right. With me as the corporate secretary.

16 Q All right. And would those books and  
17 records be available to Illinois auditors for  
18 inspection upon request?

19 A Sure. Of course.

20 Q All right. Now, I'm looking at the  
21 application; it says that the company is located in  
22 **Titusville (ck)**, Florida.

1           A     That's changed.  They just recently in the  
2     last two weeks closed that office.

3                     So, I guess that was something we  
4     overlooked as far as when the application went out  
5     and having this conversation with you.

6           Q     Okay.  What address would go down for the  
7     Applicant's location?

8           A     Okay.  That would be -- are you ready?  
9     It's a long one.

10          Q     Go ahead.

11          A     3993.

12          Q     3993.

13          A     Howard Hughes, H-u-g-h-e-s.

14          Q     Oh, Howard Hughes.

15          A     I get that age in because everyone spells  
16     differently.

17          Q     Okay.

18          A     Parkway.

19          Q     Howard Hughes Parkway.

20          A     Suite 250.

21          Q     Okay.

22          A     Las Vegas, Nevada 89109.

1 Q 89109.

2 Okay. Just to repeat. That's 3993  
3 Howard Hughes Parkway, Suite 250, in the Las Vegas,  
4 Nevada 89109.

5 A Correct.

6 Q Let the record reflect that the application  
7 is amended to incorporate -- or to include the new  
8 address and that replaces the Titusville, Florida  
9 address.

10 A Okay.

11 Q All right. Are there any books and records  
12 kept at the Las Vegas address?

13 A No.

14 I mean, there's a phone bill that's  
15 paid, and I think that's it. Yeah, because they  
16 forward all the bank statements and everything to me  
17 here.

18 Q All right. With regard to the financial  
19 data and the management profiles that were submitted  
20 for our e-docket, to your knowledge, are there any  
21 changes in those documents as we speak today?

22 A In the financial?

1 Q Right.

2 A Okay. Let me glance through this.

3 I don't think so. But then, again, I  
4 didn't think about that change of address either.

5 We sent you financial statements...

6 Q With a balance sheet and a profit and loss  
7 statement both as of 9/30/04?

8 A Okay. All right. Let's see.

9 No, there hasn't been any major  
10 changes as far as any increased assets and  
11 liabilities or anything like that.

12 Q Okay. And with regard to management  
13 profiles, are those still essentially correct?

14 A That's correct --

15 Q All right.

16 A -- just Deborah and myself.

17 Q All right. And who would do the technical  
18 support for the Applicant in the event that it's  
19 needed? Would that be the Applicant itself or would  
20 that be with an underlying carrier?

21 A Can you repeat that question.

22 Q Certainly.

1                   Who would do the technical support for  
2 you?

3           A     As far as customer service?

4           Q     Exactly. Or...

5           A     Yes, we have -- we outsource that to a  
6 customer service company in **Winter Park (ck)**, Florida  
7 there.

8           Q     Okay. So, you'll contract out for such  
9 services?

10          A     Exactly.

11          Q     All right. And will the Applicant be  
12 adhering to all federal and state laws and  
13 regulations with regard to slamming and cramming?

14          A     Absolutely.

15          Q     Okay. And will the Company be offering  
16 operator assisted services or will that be handled by  
17 an underlying carrier?

18          A     Assisted services as far as 411?

19          Q     Right. Or any operator assisted services.

20          A     No, we would not offer any of those.

21          Q     Okay. That is pretty much all of the  
22 questions that I have.

1           A     Okay.

2           Q     The only two things I want to deal with, I  
3     want to mark the management profiles that were  
4     submitted to our e-docket system. I want to mark as  
5     Applicant's Exhibit 1, and the balance sheet and the  
6     profit and loss statement I want to mark as  
7     Applicant's Exhibit 2; that's also on the e-docket  
8     system.

9                     And I will take it that you are moving  
10    for the admission of both of these exhibits into  
11    evidence?

12          A     Okay.

13          Q     And that motion is granted?

14          A     Okay.

15                             (Whereupon, Applicant's Exhibits  
16                             Nos. 1 & 2 was admitted into  
17                             evidence.)

18          Q     Do you have anything that you wanted to  
19    offer -- anything further that you wanted to offer in  
20    support of the application?

21          A     No.

22                     I mean I don't know of anything that I

1       should offer.

2               Q     No?

3                       Okay.  That's quite all right, then.

4                       I will direct the court reporter to  
5 mark this matter heard and taken and I will have an  
6 order prepared for the Commission just as soon as I  
7 can.

8               A     Okay.  Thank you very much.

9               Q     Ms. Stein, thank you very much for your  
10 cooperation.  Good day, now.
