**NICOR GAS COMPANY’S THIRD MOTION TO
CORRECT THE TRANSCRIPT OF HEARINGS**

Northern Illinois Gas Company d/b/a Nicor Gas Company (“Nicor Gas”), pursuant to Section 200.580 of the Illinois Commerce Commission’s (the “Commisison”) Rules of Practice, respectfully moves the Administrative Law Judges (the “ALJs”) to direct that the following corrections be made to the transcript of hearings that have been held in this matter. Nicor Gas brings this Motion with respect to the hearings held on May 24, 2005. Nicor Gas previously filed separate motions to suggest corrections to the transcript for the hearings held on May 18-20, 2005 and May 23, 2005. Nicor Gas plans to file an additional motion to suggest corrections to the transcript for the hearings held on May 25-27, 2005.

In support of this Motion, Nicor Gas states as follows:

1. Hearings were held in this matter on May 18 through 20, and 23 through 27, 2005. At the end of the hearing on May 27, 2005, the record in this matter was marked “Heard and Taken”.

2. Section 200.580 of the Commission’s Rules of Practice states that “[s]uggested corrections to the transcript of record must be filed within 35 days from the day on which the hearing is held” It also states that, “[i]f no objection is made to the suggested corrections,

the Hearing Examiner may, in his or her discretion, direct the corrections to be made and the manner of making them.” 83 Ill. Admin. Code § 200.580(d). The purpose of this determination is to “ensure the accuracy of the record.” Id.

3. In accordance with Section 200.580, Nicor Gas makes suggestions for corrections to the transcript for the hearings conducted on May 24, 2005, as stated on the attached table. The majority of these corrections are editorial or typographical, although several ensure the substantive accuracy of the records. The suggestions for corrections to the transcript are verified. Nicor Gas previously filed a separate Motion to suggest corrections to the transcript for the hearings held on May 18-20, 2005 and on May 23, 2005. Nicor Gas plans to file an additional motion to suggest corrections to the transcript for the hearings held on May 25-27, 2005.




