COMPANY L.P. NOTICE OF RESOLUTION OF ISSUES**

Viola Home Telephone Company and Sprint Communications L.P. d/b/a Sprint Communications Company L.P. (“Sprint”), by and through respective counsel, hereby notify the Illinois Commerce Commission (“Commission”) that Viola Home Telephone Company and Sprint have reached resolution of the issues in dispute between them in the above-captioned proceeding. In support of this notice, the parties state the following:

1. Today, Viola Home Telephone and Sprint filed with the Commission, in Docket No. 05-0585, a Joint Petition for Approval of a Negotiated Interconnection Agreement (the “Agreement”), requesting the Commission to review and approve the Agreement, dated September 8, 2005, pursuant to Sections 252(a)(1) and 252(e) of the Federal Telecommunications act of 1996, 47 U.S.C. 252(a)(1) and 252(e) (the “Act”).

2. Through the execution of this Agreement, all issues in dispute between Viola Home Telephone Company and Sprint which were raised in the Commission’s Docket Nos. 05-0402 and 05-0433 (consolidated) are resolved. Viola Home Telephone Company and Sprint have agreed to hold all filing and hearing dates in these dockets, applicable to Viola Home Telephone Company and Sprint, in abeyance pending the

Commission's approval of the Agreement. At such time, Docket Nos. 05-0402 and 05-0433 will be resolved as they relate to Viola Home Telephone Company and Sprint.

3. Viola Home Telephone Company and Sprint hereby state that the issues in dispute between the two parties are resolved upon issuance of a Commission Order approving the Agreement.
