**ROBINSON CURLEY & CLAYTON, P.C.'S**  
**NOTICE OF WITHDRAWAL OF APPEARANCE**

Susan Valentine and Robinson Curley & Clayton, P.C.'s hereby withdrawn their appearance previously filed on behalf of both Gregg E. Szilagyi, as Chapter 11 Trustee for Resource Technology Corporation ("RTC"), and the estate of RTC.

1. On November 15, 1999, an involuntary petition under Chapter 7 of the Bankruptcy Code was filed against RTC. On January 18, 2000, RTC consented to the entry of both an order for relief and one converting the case to one under Chapter 11 of the Bankruptcy Code. These orders became effective February 1, 2000.

2. On August 26, 2003, Gregg E. Szilagyi was appointed Chapter 11 Trustee for RTC.

3. On August 15, 2005, Susan Valentine and Robinson Curley & Clayton, P.C., filed their appearance as counsel of record for Gregg E. Szilagyi as Chapter 11 Trustee for RTC and for RTC individually. At the time this appearance was filed, it was anticipated that the Bankruptcy Court would grant the Chapter 11 Trustee's Motion to Dismiss the RTC bankruptcy, and that Ms. Valentine and Robinson Curley & Clayton, P.C. would represent RTC after the dismissal of the bankruptcy.

4. Instead, the Bankruptcy Court denied the dismissal motion, and on September 21, 2005, the Bankruptcy Court converted the RTC Chapter 11 case to a case under Chapter 7 of the Bankruptcy Code. *See Exhibit A.*

5. By letter dated September 26, 2005, Jay Steinberg was appointed the Chapter 7 Trustee for RTC. *See Exhibit B.* Since his appointment, Mr. Steinberg has informed Robinson Curley & Clayton, P.C. that it has not been retained to take any action with regard to this proceeding on behalf of RTC or the Chapter 7 Trustee.

**WHEREFORE,** Susan Valentine and Robinson Curley & Clayton, P.C. hereby withdraw their appearance.




