**AGREED MOTION TO EXTEND  
TIME FOR FILING CONFORMING AMENDMENT**

Illinois Bell Telephone Company (“SBC Illinois”), by its attorneys, respectfully moves the Illinois Commerce Commission (“Commission”) to extend the time in which to file the conforming Amendment to the Interconnection Agreement (“Amendment”) to December 30, 2005. In support of this Motion, SBC Illinois states as follows:

1. On November 2, 2005, the Commission issued a lengthy Arbitration Decision in this Docket, resolving approximately 33 disputed issues.

2. The Commission ordered the parties to file their conformed amendment for Commission approval within 15 calendar days of the date on which the Arbitration Decision was served. Such filing would have been required on November 18, 2005.

3. After engaging in negotiations to conform the Amendment with the Arbitration Decision, the parties determined that they needed additional time to complete their work and requested an extension of time to November 30, 2005. That request was granted by the Commission on November 16, 2005.

4. The parties have resolved their disputes that arose in the conforming process and have now reached agreement on a TRO/TRRO Amendment that reflects the rulings in the Arbitration Decision. The conformed *TRO/TRRO* Amendment is attached hereto as Exhibit A.

5. Additional time is required due to the time and effort required in order for SBC Illinois to prepare a conforming amendment for each participating CLEC, obtain signatures from the appropriate persons at each CLEC, and prepare and file a separate petition for approval of the amendment with each CLEC. There are approximately 45 separate CLECs for whom this process must be completed.

6. SBC Illinois is authorized to represent to the Commission that all other parties participating in the conforming process support this request for an extension of time up to and including December 30, 2005.

7. Counsel for Staff has informed SBC Illinois that it has no objection to the extension of time requested in this Motion.

8. Prior to December 30, 2005, the parties will diligently continue their efforts to execute and file all of the Amendments for submission to the Commission.

WHEREFORE, SBC Illinois respectfully moves the Commission to extend the time in which to file the complete TRO/TRRO Amendments to December 30, 2005.
