**DESCRIPTION OF IMPROVEMENT ORDERED:**

Lower the pavement of each roadway to provide a minimum of 14.0 feet of vehicular clearance under the existing structures.

**STATUS OF WORK:**

All right-of-way has been acquired except two parcels. Plans have been reviewed and approved by the CNIC Railroad.

A field check has been completed by the Illinois Department of Transportation and they have reviewed the plans.

Once the final two parcels of right-of-way have been acquired, plans will be sent to IDOT and a letting will be scheduled.
