BlueStar Energy Services, Inc. ("BlueStar") hereby moves to adopt the Exceptions filed by Direct Energy Services LLC on December 19, 2005, as its own. In support of its Motion, BlueStar states as follows:

1. BlueStar is a certified alternative retail electric supplier ("ARES") in the ComEd service territory, by virtue of the Commission's Order in Docket No. 04-458. BlueStar was subsequently certified in 2005 as the first ARES eligible to offer retail electric service to residential customers in Illinois.
2. BlueStar is an independent ARES, unaffiliated with any utility or generation assets, with offices in Chicago and Peoria. BlueStar services commercial, industrial, and governmental customers throughout the ComEd and other service territories.
3. The Brief on Exceptions submitted by Direct Energy Services LLC correctly and persuasively identifies numerous shortcomings in the Proposed Order, and suggests suitable language to correct these problems. Acceptance of the Exceptions proposed by Direct Energy

Services LLC will greatly assist in developing a truly competitive market that is beneficial for all stakeholders.

WHEREFORE, BlueStar Energy Services, Inc. moves to adopt the Brief on Exceptions of Direct Energy Services LLC as its own.
