PETITION FOR SUPPLEMENTAL ORDER

NOW COMES Norfolk Southern Railway Company by and through its attorney, Neil F. Flynn, and for its Petition For Supplemental Order states as follows:

1. The Commission entered its Order in this docket on March 23, 2005, and therein directed that the safety improvements be completed within twelve (12) months of the date of that Order (i.e., by March 23, 2006).

2. Construction of these safety improvements by Norfolk Southern was originally scheduled to be performed and completed during the Fall of 2005. As a result of Hurricane Katrina, Norfolk Southern sustained extensive damage to its system. Construction forces previously scheduled to perform the improvements ordered by the Commission in this docket were required to be diverted to complete the repairs necessitated by Hurricane Katrina.

3. Norfolk Southern has endeavored to complete the work within the time frame ordered by the Commission - by March 23, 2006. However, for the reasons above stated, Norfolk Southern is unable to complete the required improvements by March 23, 2006.

4. Norfolk Southern's Petition For Supplemental Order is timely filed and in accordance with the terms of the Commission's Order in this docket entered March 23, 2005.


