

ON OCT 24, 2005 THEY SENT US A LETTER SAYING AS A RESULT OF PAYMENT INFORMATION OBTAINED FROM A LOCAL NATURAL GAS UTILITY, THEY WILL NOT BECOME ARE GAS SUPPLIER. A CALL TO ARE GAS SUPPLIER, PEOPLES ENERGY 866-556-6004 TOLD US THAT PEOPLES ENERGY NEVER GIVES OUT ANY CREDIT INFORMATION. AFTER MANY PHONE CALLS I FOUND OUT U.S. ENERGY USES EQUIFAX 877-726-7311 FOR CREDIT RATINGS. I HAD TO PAY EQUIFAX TO GET MY CREDIT SCORE WHICH WAS 811, A VERY HIGH RATING. U.S. ENERGY CORP LIED ABOUT ARE CREDIT SO THEY WOULD NOT HAVE TO HONOR THEIR CONTRACT AT 90.5 CENTS PER THERM. THE SALES MAN G OAKS CAME BACK AND GOT MY WIFE TO SIGN A NEW CONTRACT AT \$1.30 PER THERM. MY WIFE HAD A BRAIN TUMOR REMOVED 12 YEARS AGO AND HAS A HARD TIME UNDERSTANDING CONTRACTS, SUDDENLY AT \$1.30 PER THERM ARE CREDIT WAS GOOD.


