NTS SERVICES CORP.**


NOW COMES NTS SERVICES CORP. ("NTS") by its attorneys, McNamara & Evans and pursuant to the Rules of the Illinois Commerce Commission ("Commission"), including 83 Ill.Admin.Code Part 200.190, hereby files this Motion requesting confidential treatment by the Commission of any and all financial information submitted by NTS in support of its Application filed herein on June 7, 2006, and in support thereof states as follows:

1. Pursuant to Question No. 25 in the Application For Certificate To Become A Telecommunications Carrier, as part of the application process for obtaining a certificate for local or interexchange authority to operate as a reseller or facilities based carrier of telecommunications services in the State of Illinois, applicants are required to submit sensitive financial data, including income statements and balance sheets.
2. NTS's financial information and related documentation are proprietary and highly confidential business records containing critical, commercially sensitive, and competitively significant data that is not available to the general public. Public disclosure of the information would place NTS at a significant competitive disadvantage, impede full and fair competition, and undermine NTS's business plans in Illinois and elsewhere. In contrast, confidential treatment of the information will not

adversely affect any interested party.

3. Accordingly, NTS respectfully requests that the Commission grant NTS's request for confidential treatment of any and all financial information submitted by it in support of its Application for a certificate to become a telecommunications carrier in the State of Illinois.
