MOTION TO CORRECT TRANSCRIPT

NOW COMES the Staff of the Illinois Commerce Commission (“Staff”) and pursuant to Section 200.580 of the Rules of Practice (83 Ill. Adm. Code 200.580) presents this Motion suggesting corrections to the transcript.

1. Central Illinois Light Company d/b/a AmerenCILCO, Central Illinois Public Service Company d/b/a AmerenCIPS, and Illinois Power Company d/b/a AmerenIP (“AmerenCompanies” or the “Companies”) filed new tariff sheets on December 27,

2005, in which the Companies proposed a general increase in rates for delivery services.

2. Hearings were held in Springfield, Illinois on July 24, 2006 through July 27, 2006.

3. A record of the hearings was transcribed by a reporter appointed by the Commission.

4. The transcripts of the hearings held on July 24, 2006 through July 27, 2006 were filed with the Chief Clerk's Office on August 7, 8, 11, and 16, 2006 respectively.

5. The transcript contains the following scrivener's errors:

- Page 370, line 8: "17" should be "7"
- Page 472, line 3: "and" should "in"
- Page 473, line 13: "utilities, plants and service" should be "utility plant in service"
- Page 474, line 3: "utilities, plant and service" should be "utility plant in service"
- Page 478, line 10: "Illinois" should be "verbal"
- Page 479, line 18: "provided" should be "requested"
- Page 479, line 19: "gave some" should be "engagement"
- Page 479, line 21: "today" should be "to date"

- Page 479, line 21: “Columns B & E” should be Columns C & E”
- Page 484, line 10: “and a number” should be deleted
- Page 485, line 4: “more to NERA” should be “more than NERA”
- Page 490, line 21: “file” should be “costs”
- Page 494, line 10: “complies” should be “compliance”
- Page 567, line 15: “November” should be “April”
- Page 583, line 10: “since” should be “at the time of”
- Page 789, line 11: "A. I am a staff..." should be "A. I am on staff..."
- Page 791, lines 7-8 & 14-15: "...Rider QL..." should be "...Rider QF...")
- Page 792, line 6: "...upon their voided..." should be "...upon their avoided..."
- Page 793, lines 4 & 16: "...MISO LNP..." should be "...MISO LMP..."
- Page 793, line 7: "...Rider MP..." should be "...Rider MV..."
- Page 794, lines 14 & 16: "...MISO LNP..." should be "...MISO LMP..."
- Page 795, lines 8-9: "A. Hourly is what the LNP price was discussed earlier." should be "A. Hourly is what the LMP price was, discussed earlier."
- Page 804, line 9: “parens it is” should be “parenthesis”
- Page 1020, line 2: “. . . had . . .” should be “. . . have . . .”

WHEREFORE, the Staff respectfully suggests that the above enumerated corrections be made to the transcript.
