

GREEN ROUTE – BALDWIN TO RUSH ISLAND

Beginning at the Baldwin Power Plant switchyard located in the Northwest Quarter of the Northwest Quarter of Section 11, Township 4 South, Range 7 West of the 3rd P.M., Randolph County, Illinois; thence extending Easterly approximately 300 feet; thence deflecting Southwesterly approximately 1.1 miles through Sections 11, 14, and 15 in said Township and Range; thence deflecting Southwesterly and extending approximately 3.1 miles through parts of Sections 15, 22, 21, 28, and 29 in said Township and Range; thence deflecting Northwesterly and extending approximately 1.3 miles through Sections 29, 20, and 19 in said Township and Range; thence deflecting Westerly and extending approximately 6.4 miles through the South Half of Section 19 in said Township and Range and the South Half of Sections 24, 23, 22, 21, 20, and 19 in Township 4 South, Range 8 West of the 3rd P.M., Randolph County, Illinois to the Monroe County line; thence continuing Westerly in Monroe County, Illinois and extending approximately 6 miles through the South Half of Sections 24, 23, 22, 21, 20, and 19 in Township 4 South, Range 9 West of the 3rd P.M.; thence deflecting Northwesterly and extending approximately 1.7 mile through Sections 24 and 23 in Township 4 South, Range 10 West of the 3rd P.M.; thence deflecting Westerly and extending approximately 0.5 miles in Sections 23 and 22 in said Township and Range; thence deflecting Southwesterly and extending approximately 0.7 miles in Section 22 in said Township and Range; thence deflecting Westerly and extending approximately 0.3 miles in Sections 22 and 21 in said Township and Range; thence deflecting Southerly and extending approximately 0.2 miles in Section 21 and 22 in said Township and Range, thence deflecting Southwesterly and extending approximately 0.3 miles in Sections 21 and 28 in said Township and Range, thence deflecting Southeasterly and extending approximately 0.3 miles in Section 28, in said Township and Range, thence deflecting Southwesterly and extending approximately 2 miles in Sections 28, 33, and 32 in said Township and Range, thence deflecting Northwesterly and extending approximately 1.1 miles in Sections 32 and 31 in said Township and Range, thence deflecting Southwesterly and extending approximately 1.1 miles in Section 31 in said Township and Range and Section 36 in Township 4 South, Range 11 West of the 3rd P.M. and Section 1, Township 5 South, Range 11 West of the 3rd P.M. to the Illinois / Missouri State line; thence continuing Southwesterly approximately 0.5 miles to a point of termination at the switchyard of the AmerenUE Rush Island Power Plant in Missouri.
