Here is a new order from the Illinois Commerce Commission about work at the noted crossing.

Mr. Ellis, as currently there are no automatic warning devices present, NSR is required to put up temporary stop signs by February 9, 2007 and then notify the ICC that we have done so within five days of the completion of that work. I would be happy to tell the ICC of this completion, or you can tell them directly.

Mr. Ellis, also note that some surface work is required by January 10, 2008.

Mr. Ray, certain AFLS/Gates/CWT work is required by January 10, 2008.

NS is required to provide an update every six months on our progress on the project.

All billing must be done by January 10, 2009.
