Amended ANSWER TO COMPLAINT

Now comes the Respondent, The Peoples Gas Light and Coke Company, by and through its attorney, Mark L Goldstein, and files its Answer to the Complainant of Complainant, Johnny L Womack, as follows:

1. Respondent admits that on May 19, <sup>2005</sup>1995, it posted a Final Notice Prior to Disconnection at Complainant's building at 8100 South <sup>Cellis</sup>Peoria, Chicago, Illinois (the "Building").
2. Respondent denies that Complainant was not allowed to make payment arrangements with the Respondent.
3. Respondent admits that in May, not April, 2005, Respondent terminated service to the Building
4. Respondent denies all the allegations set forth in Paragraph 4 of the Complaint and states that Complainant owes Respondent \$10,797.88 for gas service rendered to the Building.

WHEREFORE, Respondent respectfully requests that the complaint filed by Johnny L. Womack on October 12, 2006 be dismissed with prejudice.


