**VERIFIED PETITION TO INTERVENE OF  
EDISON MISSION MARKETING & TRADING, INC.**

Pursuant to 83 Ill. Admin. Code Section 200.200, Edison Mission Marketing & Trading, Inc. (“EMMT”) hereby petitions the Illinois Commerce Commission (“Commission”) for leave to intervene as a party in the above-captioned matter. In support of this petition, EMMT states as follows:

1. EMMT is a California corporation with an office located at 160 Federal St., 4th Fl., Boston MA 02110-1776.
2. EMMT is a wholly owned subsidiary of Edison Mission Energy (EME) and an affiliate of Midwest Generation EME LLC (MWGen). EME is an independent power producer engaged in developing, acquiring, owning and leasing, and operating electric generating facilities.
3. EMMT trades in U.S. domestic electricity, natural gas, crude oil, heating oil, unleaded gasoline and emission allowances, as well as associated financial trading. MWGen and its affiliated companies own and operate generation facilities in the State of Illinois.

Through EMMT, MWGen sells electric power and energy at wholesale in the regional PJM and MISO markets.

4. EMMT participated in the auction process (the "Illinois Auction") at issue in this proceeding. As a potential supplier of electric power to Commonwealth Edison Company in future Illinois Auctions, EMMT has an interest in and will be affected by any decision of the Commission in this proceeding.

Wherefore, Edison Mission Marketing & Trading, Inc. requests that this Petition to Intervene be granted and that EMMT be treated as a party to this proceeding.


