Re: Circuit ordered for Gjvoick Auto in Sandwich IL in May of 2005

In regards to the discussion we had last week about the Verizon bill I received on the Gjvoick circuit (SBC circuit ID # HCGS.929718). I've had time to pull all the backups of Erik's email and review them. There is no Verizon contract with the order and the SBC contract lists the customer address as the Z end of the circuit. I do see where you listed that the last 9% of the circuit was Verizon but never said it was not included in the contract. If in fact you were only providing transport to the last SBC POP that should have been stated on the contract. I'm sure your legal department will tell you that it is the reasonability of the party drafting the contract to specify clearly what is included. Anything left open to interpretation will be ruled in favor of the other party.

I've contacted Verizon on the bill we received from them and they tell me that a contract for 60 months was signed by or for Apps Communications in July of this year. I have signed no such contract. The contract was requested in May of 2006 by Mandy and returned in July of 2006 by Mandy. I have requested a copy of the contract be sent to me.

Walter when I asked you last week why if the Verizon portion of this circuit was not included in the SBC contract I was not given a Verizon contract back in May of 2005 with the SBC contract. Your response was that the Verizon portion of the circuit was my responsibility and that you could supply a Verizon contract. If that is the case why is Mandy requesting a Verizon Contract for this circuit now and who signed the contract for Apps Communications?

There seems to be a problem with this circuit. I never signed a contract with Verizon in 2005 and I did not sign the contract with Verizon in May, June or July of this year.

I would suggest we get to the bottom of this before it gets to a point were Lawyers are brought in.

I have sent a copy of this email to United Forensics; I will be working with them and handwriting experts to analyze the Verizon contract.
