Notice is hereby given of the following corrections to the transcript. Nothing in this notice shall preclude any party from moving for further corrections.

February 21, 2007

- 87: Lines 5-6 should state “motion for an Order limiting and conditioning discovery and for an emergency hearing” [as provided on the motion itself and the notice of hearing] rather than “motion in limine conditioning discovery for emergency hearing.”
- 105: Line 14 should state “going” rather than “claiming.” Line 21 should state “broader than necessary” rather than “brought into the necessary.”
- 106: Line 2 should state “problematic in light of ...” rather than “problematic in like of ...”
Line 21 should state “representation from one, and no response to another.”
- 109: Line 11 should end with the phrase “underscore the confidentiality of the information.”
- 110: On line 4, “trip” should be “intrude.”
- 111: On line 18, “previously amended” should be “pleadings are amended.”

March 1, 2007

- All: Every reference to Ms. Littmann should be to Ms. Lippmann.
- 126: Line 13 should state “the associated documents...”

146: Line 5 should state “implementing” rather than “complementing.”

March 6, 2007

388: The discussion of briefing should read “the initial round” rather than “the initial ground” at line 5.

155: The following changes should be reflected on the exhibit page:

Line 5b: IAWC ex. 1.0-sup and A&B were admitted, not just marked, on 163.

Line 6b: Champaign/Urbana was labeled as ex. 3 (presented at trial) rather than 3.0 (numbering used for their pre-filed exhibits).

Line 11b: Staff ex. should be 5.0, not 6.0.

Line 15a: 2.1R, not 2.01R

Line 17b: This line should identify Champaign ex. 1.0 and 2.0, and Urbana ex. 1.0, 2.0, and 2.01, all of which are identified on 385 and admitted on 387.

Line 20a: ex. 1.07 should be ex. 1.01; the three exhibits were identified on 386 and admitted on 387.
