**ERRATA SHEET**

Pursuant to the ALJs' instructions during evidentiary hearing on June 1, 2007, Rockwell Utilities, LLC ("Rockwell"), through its attorneys, hereby submits this Errata to the Surrebuttal Testimony Jeremy C. Lin (Rockwell Ex. 10.0), as follows:

1. Page 3, ln. 56 - after "Second," delete the remaining portion of the sentence and insert "the existing facility in fact does have 150 days winter storage volume for the permitted 3,210 P.E. capacity based on the first cell and second cell lagoons having reserve volume.
2. Page 3, ln. 61 - after the word "required" delete the remaining portion of the sentence and insert "that necessitates construction, the cost of the construction would reduce the purchase price by an equal amount. Pursuant to Paragraph 2(e) of the Asset Purchase Agreement, Rockwell's costs to purchase the facility and to expand the facility's capacity may not exceed the Maximum Purchase Price. Any costs in excess thereof would be paid by the seller."

3. Page 5, ln. 90 - change "JPC-2.3" to "JCL 2.3".
4. Page 5, ln. 92 - change "JPC-2.3" to "JCL 2.3".
