Despite ICRR's good-faith efforts to complete the stated work by August 30, 2007, and due to a shortage of manpower, other ongoing signal projects, and materials that have been ordered but not yet received, ICRR's crews have been unable to complete all of the required work within one (1) year of the date of the Order.

WHEREFORE, IC, respectfully requests that the Commission;

- a) Extend until November 30, 2007, the time to complete the work stated in the Order; and
- b) Provide such other and further relief as the Commission deems just and appropriate.


