THE PEOPLES GAS LIGHT AND COKE COMPANY’S FOURTH ERRATA**


North Shore Gas Company (“North Shore”) and The Peoples Gas Light and Coke Company (“Peoples Gas”), by their counsel, are providing this notice of their fourth errata.

This fourth errata contains two corrections to North Shore witness Valerie H. Grace’s Direct Testimony (North Shore Ex. VG-1.0 Rev). First, on line 198, “Ex[.] VG-1.5, page 1 of 3” has been corrected to read “Ex. VG-1.4, page 1 of 2”. Second, on lines 200-201, the phrase “while lines 6-9 show the allocated cost resulting from applying the EPEC method” has been removed. These changes are made in the attached copy of the testimony.

In addition, a correction has been made to North Shore and Peoples Gas witness James Schott’s Surrebuttal Testimony (North Shore / Peoples Gas Ex. JFS-3.0). Lines 179-182 of this testimony have been removed, because they refer to another witness’ attachment of certain tariff sheets which were not attached to her testimony.
