ORDER ON REOPENING

I. Introduction:

PT Communications, Inc. ("Petitioner") states that on January 10, 2007, the Commission granted it a Certificate of Service Authority and Certificate of Exchange Service Authority to provide telecommunications services in Illinois. It subsequently came to Petitioner's attention that page one of its original application erroneously contained the Federal Employer Identification Number ("FEIN") of its affiliate company, WDT World Discount Telecommunications Co. ("WDT").

II. Petition

On August 24, 2007, Petitioner filed a Petition to Reopen this Docket for the purpose of replacing page one of its original application with a page one that contains Petitioner's correct FEIN. The corrected page one of the petitions containing Petitioner's FEIN was attached to the Petition to Reopen and marked Exhibit A. For the reasons set forth below, we grant Petitioner's motion.

There were no contested issues raised by the Petition to Reopen and the Administrative Law Judge waived the hearing.

III. Conclusion

83 Ill. Adm. Code Part 200.900 provides, in relevant part, that the Commission, after issuance of an Order, may "...reopen any proceeding when it has reason to believe that conditions of fact or law have so changed as to require, or that the public interest requires, such reopening." The Commission finds that it is proper under Part 200.900 to reopen a docket to correct an error. Petitioner's Motion to Reopen should be granted and the original page one filed with the wrong FEIN should be replaced with the attached page one marked Exhibit A, containing Applicant's correct FEIN. This record in this docket should be closed after entry of this Order on Reopening.

IV. Findings and Ordering Paragraphs

The Commission, having considered the entire record herein on reopening and being fully advised in the premises, is of the opinion and finds that:

- (1) the record in this docket should be reopened pursuant to 83 Ill. Adm. Code 200.900 for the sole purpose of replacing page one of the original application containing the erroneous FEIN with the page one marked Exhibit A attached to the Motion to Reopen and containing Petitioner's correct FEIN;
- (2) in all other respects the record in this docket remains unchanged;
- (3) the record in this docket should be closed after entry of this Order on Reopening.

IT IS THEREFORE ORDERED that the record in this docket is reopened pursuant to 83 Ill. Adm. Code 200.900 for the sole purpose of replacing page one of the original application containing the incorrect FEIN with the page one marked Exhibit A attached to the Motion to Reopen containing Petitioner's correct FEIN.

IT IS FURTHER ORDERED that the record in this docket otherwise remains unchanged.

IT IS FURTHER ORDERED that this docket is closed after the entry of this Order on Reopening.

IT IS FURTHER ORDERED that subject to the provisions of Section 10-113 of the Public Utilities Act and 83 Ill. Adm. Code 200.880, this Order is final; it is not subject to the Administrative Review Law.
