Petitioner Clinton A. Krislov, acting pursuant to Illinois Public Utilities Act §10-201, 220 ILCS 5/10-201, and the Commission's Rules of Practice §200.890 , 83 Ill.Adm.Code 200.890, hereby appeals to the Appellate Court of Illinois, First Judicial District, for review of the orders issued by the Illinois Commerce Commission in Docket 06-0421, including but not limited to: July 11, 2007 (granting Respondent AT&T Illinois' motion to dismiss), and August 31, 2007 (denying the Petitioner Krislov's Petition for Rehearing).

By this appeal, Petitioner Krislov asks the appellate court to reverse the Orders of the ICC dismissing Petitioner's Complaint on the basis that Krislov is precluded from petitioning the ICC because he is a member of the settlement class, and to find that AT&T Illinois is in violation of Illinois Commerce Commission's Regulation (83 Ill. Admin. Code Chap. I, Section 735.160(a))

by charging late fees on customer bills which do not have a postmark.
