PETITION FOR LEAVE TO INTERVENE

NOW COMES Art Washkowiak, Mayor of the City of LaSalle, through its attorneys, Anthony C. Raccuglia & Associates, P.C., and respectfully petitions the Illinois Commerce Commission for leave to intervene in the above-captioned proceeding, and in support thereof states as follows:

1. That the City of LaSalle, a home-rule municipality, is located in LaSalle County, Illinois, and that the "Y" (yellow) alternative route, amongst other routes, is apparently now under consideration by the Illinois Commerce Commission; and the same crosses partials of real estate located within the City's municipal boundaries.

2. That additionally the "Y" (yellow) alternative route does cross City right-of-way; and thus the City of LaSalle additionally maintains, among other things, that the City of LaSalle should have provided formal notice that the "Y" (yellow) route was being considered by the Illinois Commerce Commission, as opposed to having had to learn of the same through third parties; and the City objects to any substantive hearing on this "Y" (yellow) route without notice, and having an opportunity to prepare and be heard.

3. That the City of LaSalle has been on record with AmerenIP as being in

opposition to the "Y" (yellow) route from the first discussed, and the City of LaSalle was of the understanding that for valid reasons, that route was rejected by AmerenIP; and was not any longer being considered.

4. That the City of LaSalle, though it did not receive notice of the upcoming status hearing, has recently been advised that the "Y" (yellow) route is again being considered; and for the record, this proposed intervener encloses its proposed formal Objection to the "Y" (yellow) alternative route, as its attached Exhibit "A" hereto, which Objection also includes as an Exhibit thereto a copy of the City's communication to AmerenIP back on June 12, 2006, indicating among other things the City's opposition to that which is now referenced as the "Y" (yellow) alternative route.






