MOTION TO APPEAR PRO HAC VICE

We, THOMAS K. CROWE and JOHN M. WONG, pursuant to §200.90 of the Illinois Commerce Commission's ("Commission") Rules of Practice (*see* Ill. Adm. Code Title 83, §200.90 and 220 Ill. Comp. Stat 5, §10-101) hereby move for permission to represent Optic Internet Protocol, Inc. ("OIP") in the above-captioned proceeding upon special leave of the Hearing Examiner. In support thereof we hereby state:


3. Good cause exists for our admission *pro hac vice*, in that we represent OIP, we are their authorized agents, and we are familiar with OIP's business plans and operations.




