MOTION FOR CONFIDENTIAL TREATMENT

BLUESTAR ENERGY SERVICES, INC., ("BlueStar"), hereby requests that the Illinois Commerce Commission ("Commission") treat Exhibits C and F of its Application to Amend Certificate of Service Authority as "Confidential" and not made part of the public record. In support of its Motion, BlueStar states as follows:

1. BlueStar is seeking to supplement its prior certificates of authority to include approval to offer Single Billing Option ("SBO") authority in the ComEd service territory.

2. Exhibits C and F, containing highly confidential financial and business strategy information, must be kept confidential as disclosure of this information would undoubtedly work a substantial hardship on BlueStar. A competitor could easily derive BlueStar's confidential and proprietary business plans from such information if made public.

3. Specifically, given the highly competitive nature of the retail electricity market in this State, forcing BlueStar to publicly disclose its estimated amount of delivery services to be billed under the SBO for the next twelve months would cause

serious competitive harm to BlueStar, and would be of no benefit other than to that of its competitors.

4. Similarly, disclosing BlueStar's highly confidential financial information would work an extreme hardship on BlueStar.

WHEREFORE, Applicant BlueStar Energy Services, Inc. respectfully requests that the Chief Clerk of the Commission treat Exhibits C and F of BlueStar Energy Services, Inc.'s Amended Application to Amend Certificate of Service Authority as Confidential, and that Exhibits C and F and the information contained therein be kept under seal and not made part of the public record of BlueStar's application, and not posted on the websites of the Illinois Commerce Commission or the Office of the Clerk for a period at not less than five years, pursuant to under 83 Ill.Adm.Code 451.160.
