PETITION

Now comes Harbor Ridge Utilities, Inc. (“Harbor Ridge” or the “Company”), pursuant to Section 9-220.2 of the Public Utilities Act (the “Act”), 220 ILCS 5/9-220.2, and hereby requests that the Illinois Commerce Commission (the “Commission”) enter an order approving the annual reconciliation for the surcharge for purchased sewer, and thereby approve an increase in the surcharge for purchased sewer. In support of its Petition, the Company states as follows:

1. Harbor Ridge is a public utility within the meaning of the Act and is engaged in the business of furnishing sewer public utility service to the public in a subdivision near Antioch, Illinois.
2. The Company’s schedule ILL.C.C. No. 11, Fifth Revised Information Sheet No. 1 provides a surcharge for sewer service to compensate the Company for the amount payable to the Lake County Public Works for purchased sewer for the Harbor Ridge subdivision. This schedule was filed on March 19, 2007 and the respective surcharge for purchased sewer (the “effective surcharge”) was effective as of April 1, 2007.
3. Pursuant to Section 655.50(d) of 83 Illinois Administrative Code (the “Code”), the annual reconciliation year for the effective surcharge begins on January 1, 2007 and ends on December 31, 2007.

4. The effective surcharge was calculated based on estimated costs of purchased sewer from Lake County Public Works and estimated customer consumption in gallons. The actual costs of purchased sewer and actual customer consumption in gallons for the reconciliation year are documented on Schedule 1, which is attached hereto.


5. The revenue arising from the effective surcharge in the reconciliation year, as indicated on Schedule 2 attached hereto, was not sufficient to cover all the costs of purchased sewer.

6. The difference between the revenue collected through the effective surcharge and the cost of the purchased sewer is documented on Schedule 3, which is attached hereto. Pursuant to Section 655.50(b)(3) of the Code, this difference is the reconciliation component (R) of the surcharge calculation.

7. Therefore, it is in the public interest that there is a proper match of expense and revenue recovery. Schedule 4, which is attached hereto, is a revised surcharge calculation that includes the reconciliation component derived from the annual reconciliation. The Lake County surcharge will increase from \$3.52 per 1,000 gallons to \$4.01 per 1,000 gallons.

Wherefore, Harbor Ridge respectfully requests that the Commission approve the annual reconciliation of the surcharge for purchased sewer pursuant to Section 9-220.2 of the Act, which thereby increases the surcharge for purchased sewer.






