

V., Operating Expenses, and Section XI. Other. These Exceptions implement the issue resolutions recommended by the Staff / ComEd Stipulation. ComEd understands that Staff is proposing identical language if the Commission approves the recommendations of the Staff / ComEd Stipulation.

- Appendix B comprises ComEd's Exception language to the Proposed Order's Commission Conclusions and Finding and Ordering Paragraphs relating to Section II., Overall Revenue Requirement and Revenue Deficiency, Section IV, Rate Base, Section V., Operating Expenses, and Section VI., Rate of Return. These ComEd exceptions should be used if the Commission does not approve the recommendations of the Staff / ComEd Stipulation.
- Appendix C comprises ComEd Exceptions to (1) descriptions of ComEd's positions throughout the Proposed Order; and (2) ComEd's Exceptions to the Commission Conclusions and Finding and Ordering Paragraphs relating to Section VI., Rate of Return, Section VII., New Riders, Section VIII., Cost of Service and Allocation, and Section IX., Rate Design.

Accordingly, ComEd requests that the Commission adopt the Exceptions in Appendices A and C. If the Commission rejects the recommendations of the Staff / ComEd Stipulation, then ComEd requests that the Commission adopt the Exceptions in Appendices B and C.

ComEd's Brief on Exceptions clearly references these documents. Exceptions are referred to as "Exception No. A-__" for Appendix A, "Exception No. B. __" for Appendix B or "Exception No. C. __" for Appendix C.
