**ORDER**

By the Commission:

On August 19, 2008, Conexion Mundial, Inc. d/b/a World Connect d/b/a El Mundo Conecta ("Petitioner") filed a petition to withdraw its authority as an Interexchange Carrier of telecommunications services in Illinois. Conexion Mundial, Inc. petitioned to cancel its Certificate of Service Authority previously issued on June 27, 2007 in Docket 07-0278. Petitioner has no interexchange customers in Illinois and has ceased its interexchange operations in the state; therefore discontinuance of service by Petitioner will not deprive Illinois customers of any necessary telecommunications service, and is not otherwise contrary to the public interest.

The Administrative Law Judge waived the hearing in this matter.

The Commission having reviewed the entire record herein and being fully advised in the premises is of the opinion and finds that:

- (1) the Commission has jurisdiction over Conexion Mundial, Inc. and the subject matter herein;
- (2) Conexion Mundial, Inc. was granted a Certificate of Service Authority issued on June 27, 2007 in Docket 07-0278 to provide interexchange services in Illinois;
- (3) on August 19, 2008, Conexion Mundial, Inc. filed a petition to withdraw the Certificate of Service Authority to provide interexchange services issued in Docket 07-0278;
- (4) Conexion Mundial, Inc. has no interexchange customers in Illinois and has ceased its interexchange operations in the state; therefore discontinuance of interexchange service by Petitioner will not deprive Illinois customers of any necessary services and is not otherwise contrary to the public interest; thus, the petition should be granted;

- (5) Conexion Mundial, Inc. should file its 2007 Annual Report within 60 days of the date of this Order.

IT IS THEREFORE ORDERED by the Illinois Commerce Commission that pursuant to 220 ILCS 5/13-406 of the Public Utilities Act the petition of Conexion Mundial, Inc. d/b/a World Connect d/b/a El Mundo Conecta to withdraw its authority to operate as a Interexchange Carrier is granted, and the Certificate of Interexchange Service Authority to operate as a facilities based carrier of telecommunications services as previously issued in Docket 07-0278 is canceled.

IT IS FURTHER ORDERED that Conexion Mundial, Inc. d/b/a World Connect d/b/a El Mundo Conecta shall file its 2007 Annual Report within 60 days of the date of this Order in compliance with Finding (5) above.

IT IS FURTHER ORDERED that subject to the provisions of Section 10-113 of the Public Utilities Act and 83 Ill. Adm. Code 200.880, this Order is final; it is not subject to the Administrative Review Law.
