STIPULATION OF UNDISPUTED FACTS

The Cook County Illinois and the Staff of the Illinois Commerce Commission hereby stipulate that the following facts are not in dispute in this proceeding:

1. Cook County, Illinois (hereafter "Cook County") is a body corporate and politic organized home rule unit of government, pursuant to the Illinois Counties Code.
2. On or about July 16, 2008, Cook County filed an Application for Certificate of Service Authority with the Illinois Commerce Commission, seeking authority to provide facilities based local and interexchange telecommunications service, and resold telecommunications service.
3. On or about July 29, 2008 and October 3, 2008, the Staff of the Illinois Commerce Commission (hereafter "Staff") promulgated and served upon Cook County, pursuant to 83 Ill. Adm. Code 200.340, its first and second set of data request respectively, requesting information relating to Cook County's Application.
4. On or about August 14, 2008 and October 2, 2008, Cook County provided responses to the first set of data requests and on or about October 20, 2008 Cook County provided responses to the second set of data requests promulgated by Staff.


5. A true and correct copy of Cook County's Responses to Staff Data QL-2.01 through QL-2.04 are attached hereto as Exhibit No. 1, and incorporated by this reference herein.

6. The information contained in Cook County's Responses to Staff Data Requests QL-2.01 through QL-2.04 is material and relevant to the resolution of this proceeding, and the parties agree that the data requests described in this section and responses are admissible and should be admitted into evidence.

7. Cook County has agreed as a matter of record that it shall comply with all federal and state rules and regulations related to telecommunications, including, but not limited to, laws concerning taxation, regardless whether its operations are inside or outside of the Illinois County of Cook.

8. Staff does not oppose granting the application.



