PETITION FOR SUPPLEMENTAL ORDER

Petitioner, Rick's Township of Christian County ("Rick's Township"), by its
Highway Commissioner, Mr. Wayne Grundy, files its Petition for Supplemental Order
and in support thereof states as follows:

1. By Order dated June 27, 2007, Rick's Township was required to reconstruct the existing south highway approach grades at the TR 54 highway-rail grade crossing of the Norfolk Southern Railway Company's track (AAR/DOT #480 015M, railroad milepost 415.00-WA) to comply with the minimum requirements of 92 Ill. Adm. Code 1535.310;
2. Rick's Township attempted to satisfy the terms of the Commission Order by making improvements to the south approach at the TR 54 grade crossing, but, upon inspection, the approach improvements were found to be unacceptable by Commission Staff;

3. Rick's Township anticipates it will need an additional six (6) months, to and including June 30, 2009, to complete the additional approach improvements called for by Commission Staff.

WHEREFORE, Petitioner, Rick's Township of Christian County, requests that the Commission enter a Supplemental Order granting it an extension of time to and including June 30, 2009 within which to complete the work ordered in the Commission's Order dated June 27, 2007.


