**PETITION TO REOPEN CASE**


COMES NOW Telecom AG, LLC ("Telecom AG"), by its undersigned counsel, hereby files this Petition to Reopen Case ("Motion") in association with its Application for a Certificate of Interexchange Authority ("Application") in the above-captioned docket. In support of this Petition, Telecom AG states as follows:

1. Telecom AG filed its Application with the Illinois Commerce Commission ("Commission") on January 23, 2008.
2. On April 23, 2008, the Commission granted Telecom AG a Certificate of Interexchange Authority authorizing Telecom AG to provide reseller telecommunications services statewide in the State of Illinois.
3. On or about February 2, 2009, Telecom AG was made aware that it's Application, and specifically Attachment 4, which contains Telecom AG's financial information in support of its Application, was available to the public via the Commission's website.
4. On March 17, 2009, the Commission directed Telecom AG that in order to remove Attachment 4 from public viewing on the Commission's website, Telecom AG should move to open this case in order to file a motion for protective treatment of Attachment 4.

5. Because Attachment 4 contains critical, commercially sensitive and competitively significant data, Telecom AG respectfully requests that this Docket be reopened so that the Commission may hear Telecom AG's motion for protective treatment in order that Attachment 4 may be granted protected treatment and removed from further public disclosure.

**WHEREFORE**, for the above reference reasons, Telecom AG respectfully requests that the Commission consider this Petition to Reopen Case.




