PETITIONER'S MOTION TO CONTINUE HEARING

NOW COMES THE PETITIONER, HENNEPIN ROAD DISTRICT, by its attorneys,
BOYLE & BOLIN, and hereby files this request to continue the hearing/conference scheduled for
10:00 A.M. April 21, and in support hereof states as follows:

1. The petitioners intend to file an amended petition.
2. The amended petition will include the following changes from the original petition:
 - a. The request to allocate the cost of the proposed move to ArcelorMital will be withdrawn and the cost therefor will be absorbed by the petitioner.
 - b. The request to grant an "exempt" status to the crossing will be withdrawn.
 - c. The Department of Transportation will be added as a party.
 - d. The owner of the railroad track in question will be added as a party.


Subsequent to the filing of the original petition, the ownership of the track in question has
now been ascertained and will be reflected in the amended petition.

3. By reason of the premises, it is appropriate to continue this hearing for a short period
of time to permit the petitioner to file the amended petition with the aforesaid changes. The


petitioner is informed and believes that, as amended, the decision on the petition will be possible in a more expeditious manner.
