Dear Ms. Rolando:

On February 25, 2009, The Peoples Gas Light and Coke Company (“Peoples Gas”) and North Shore Gas Company (“North Shore”) filed direct testimony in the above-referenced dockets. At the time of filing, information contained in the direct testimonies of James F. Schott (NS Ex. JFS-1.0 and PGL Ex. JFS 1.0) were designated confidential and proprietary. This information is now public information. As a result, on April 15, 2009, North Shore and Peoples Gas filed a Motion to Remove the Confidential and Proprietary Designation from the Direct Testimony of James F. Schott. On April 17, 2009, the Administrative Law Judges granted the Motion filed by North Shore and Peoples Gas. Therefore, we hereby submit revised public versions of Mr. Schott’s direct testimony in the consolidated dockets. The only differences between Mr. Schott’s testimony filed on February 25 and the testimony submitted today are as follows:

1. The “confidential and proprietary” designation on the cover page of each respective testimony has been removed;
2. The footer on each page of the testimony has been revised from “North Shore Ex. JFS-1.0 C&P” and “Peoples Gas Ex. JFS-1.0 C&P” to read “North Shore Ex. JFS-1.0 Rev.” and “Peoples Gas Ex. JFS-1.0 Rev.”, respectively.
3. NS Ex. JFS-1.0, p. 11, line 228: 6.7% was changed to 6.66%; and
4. PGL Ex. JFS-1.0, p. 12, line 249: 5.7% was changed to 5.64%.


