The revised tariff sheets and original tariff sheets are being issued on April 23, 2009 with an effective date of June 8, 2009.

Pursuant the Commission's final order in ICC Docket No. 04-0336 (entered December 15, 2004), Illinois-American was granted the authority to implement a Qualifying Infrastructure Plant ("QIP") Surcharge rider for the Company's Alton, Streator, Cairo, Interurban, Pontiac, and Peoria districts. The above referenced tariff sheets would implement the QIP Surcharge Rider in the Company's Champaign, Sterling, Pekin, Lincoln, South Beloit, and Chicago Metro Water and Waste Water districts. The QIP rider would operate in these additional districts in the exact same manner as it currently operates in the Alton, Streator, Cairo, Interurban, Pontiac, and Peoria districts. Supporting testimony and exhibits, as required by 83 Ill. Admin. Code 656.90, are being provided contemporaneously herewith.

Customers directly impacted by this filing are water customers in the Company's Champaign, Sterling, Pekin, Lincoln, South Beloit districts, and water and waste water customers in the Company's Chicago Metro Water and Chicago Metro Waste Water districts. Notice of this filing has been provided to the customers in the above districts in accordance with the Public Utilities Act and Commission rules.
