
MOTION TO WITHDRAW APPLICATION WITHOUT PREJUDICE

Public Wireless, Inc. ("Public Wireless" or "Company") hereby submits this Motion to Withdraw and respectfully requests that the Illinois Commerce Commission ("Commission") allow the Company to withdraw without prejudice its Application for a Certificate of Local and Interexchange Authority to Operate as a Reseller and Facilities-Based Carrier of Telecommunications Services Throughout the State of Illinois ("Application"). Public Wireless filed the Application in this docket on June 9, 2009.

Due to unforeseen circumstances, Public Wireless expects to delay its plans to expand operations into Illinois. In the interest of administrative efficiency, and after consultations with Commission Staff, Public Wireless wishes to withdraw the pending Application without prejudice to Public Wireless' ability to file a new application in the future. Public Wireless has conferred with Staff and Staff has indicated that it does not object to the withdrawal of Public Wireless' Application. Public Wireless will refile a new application at such time as the Company is able to direct sufficient resources toward its plans in the State of Illinois.

WHEREFORE, for the reason stated herein, the Company respectfully requests that the Commission approve this Motion to Withdraw.


