



On June 29, 2009, you sent MidAmerican Energy Company (MidAmerican) a letter outlining deficiencies in the Part 285 filing which was submitted with MidAmerican's June 2, 2009, gas rate case filing.

The following is provided in response to that deficiency letter along with the enclosed verification.

Code Section	Schedule	Comment	Response
285.1020	A-4	Did not include explanation of changes in conditions from the prior rate order that necessitated the filing for a change in tariffed rates.	Refer to Revised Schedule A-4.
285.1025	A-5	Did not include the allocation for each type of utility service within each service area.	Refer to Revised Schedule A-5.
285.2005	B-1	Did not reflect any ICC Account numbers.	Refer to Revised Schedule B-1.

285.2075	B-8.1	Did not reflect any accounts payable associated with materials and supplies.	MidAmerican already provided a footnote on Schedule B-8.1 (b) (3) stating "we do not record accounts payable balances and supplies in a separate accounts payable account". In addition, we have responded to data request JMO-3.03 requesting information on the accounts payable balance. Finally, MidAmerican has included a cash working capital calculation in its filing, making a calculation to remove accounts payable related to materials and supplies unnecessary. For your convenience, copies of Schedule B-8.1 and the response to data request JMO-3.03 are included.
285.2115	B-14	Did not reflect any accrued interest associated with budget payment balances.	MidAmerican Energy Company provided a footnote on Schedule B-14 which stated, "We do not accrue interest on budget payment plan balances". Additionally, we have responded in ICC Data Request JMO-1.07 a), "MidAmerican does not pay or charge interest on accrued budget balances. This is not required in Illinois". For your convenience, copies of Schedule B-14 and the response to data request JMO-1.07 are included.
285.3135	C-11.3	Did not include the amount capitalized, percentage capitalized, amount expensed and percentage expensed for each employee benefit listed in subsection (b) for the test year.	Refer to Revised Schedule C-11.3.
285.4030	D-3	Did not provide the coupon rate for the floating and variable rate issues.	Refer to Revised Schedule D-3, Revised WPD-3 and Supplemental Confidential WPD-3.1b.
285.4030	D-3	Did not provide the recent interest rates.	Refer to Revised Schedule D-3, Revised WPD-3 and Supplemental Confidential WPD-3.1b.
285.4040	D-4	Did not provide the number of shares reacquired for the first 11	Refer to Revised Schedule D-4 and Revised WPD-4.1.

285.4080	D-8	Did not provide the most recent (4-2-09) Full Analysis and Summary Report from Standard and Poor's.	Refer to Revised Schedule D-8 and Revised WPD-8.3.
285.4090	D-10	Did not provide Schedule.	Schedule D-10 was listed on page 3 of Schedule A-1 as a schedule not being provided with instructions to see Section 285.2020 Schedule B-3. Schedule B-3 is a comparative balance sheet for 2005, 2006, 2007 and 2008. For your convenience, copies of Schedule A-1 and Schedule B-3 are included.
285.6315	F-11	Need to provide the last three dates that each facility was used to serve load.	Refer to Revised Confidential Schedule F-11.
