AMENDED MOTION FOR PROTECTIVE ORDER


Job 8, LLC (“Applicant”) by its representatives and pursuant to Section 200.430 of the Illinois Administrative Code, 83 ILL. ADMIN. CODE § 200.430, hereby files this Amended Motion for Protective Order (“Motion”) in the above-captioned proceeding. Applicant requests an Protective Order to establish confidential treatment of the commercially-sensitive financial information attached as Exhibit 4 to its *Application for a Certificate of Local and Interexchange Authority to Operate as a Reseller of Telecommunications in the State of Illinois* (“Application”), filed separately with the Illinois Commerce Commission (“Commission”) on June 17, 2009. Applicant moves for the confidential treatment of the financial information contained in Exhibit 4 for a period of two (2) years from the date of the submission of this Motion.

Applicant is a private, closely-held corporation whose financial information is maintained as highly confidential and proprietary. Public disclosure of this material would materially damage Applicant’s competitive and financial positions. Further, the public interest would be protected by keeping this information confidential in that any compromise of Applicant’s competitive and financial positions would affect its ability to provide competitive telecommunications service in the state of Illinois, to the detriment of consumers.

For these reasons, Applicants submits that Exhibit 4 of the *Application* is exempt from disclose under both state and federal law. *See, eg*, 5 U.S.C. § 552; 83 ILL. ADMIN. CODE § 200.430.

WHEREFORE, for the foregoing reasons, Applicant respectfully requests that the Commission grants this Amended Motion for Protective Order governing the information contained in Exhibit 4 of the *Application*.
