ADDENDUM

NOW COMES Fred M. Morelli, Jr., attorney as aforesaid, and as an addendum to his previously filed Response states as follows:

1. New evidence:
 - a. City of Ottawa has withdrawn from the agreement
 - b. Dayton Township has passed a Resolution in opposition to the River route.
 - c. It has been made known that it will be necessary for Ameren to clear cut a swath of mature trees, 150 feet wide, starting at the west bank of the Fox River and extending nine (9) miles along the Fox River.
 - d. It is expected that Ameren will in perpetuity use herbicides to control vegetation in that 150 foot swath.

2. Public Interest:
 - a. Preservation of the ecology of the Fox River.
 - b. Prevention of herbicide runoff into the Fox River and into the Illinois River.
 - c. Public safety concerns for Ottawa Airport.
